INITIAL PRODUCTION CHECK (IPC)

It is performed at the stage of about 5%-10% products finished for inspection, to allow the revision of product quality requirements before the start of mass production. It allows timely corrections of any non-conformities detected, and improvement actions to be made prior to mass production.

DURING PRODUCTION CHECK (DUPRO)

It is performed at the stage of 30%- 50% goods finished and packed into export cartons. This inspection validates the initial production process has been maintained and that goods being produced continue to meet quality requirements. In the case of new raw materials, new operators, production lines or specification changes, this service can assess if requirements are being met during production.

FINAL RANDOM INSPECTION (FRI)

It is the most effective inspection that confirms the whole shipment's quality level. It normally requires the production to be 100% complete and at least 80% of goods to be packed into cartons. The checked samples are randomly selected according to AQL standard.

LOADING SUPERVISION (LS)

It provides witness to the loading process, to make sure the correct quantity and cartons in good condition are loaded into containers having good condition. Container Loading Supervision is an important step in receiving quality goods.



100% INSPECTION

When the production is 100% finished, before or after the products are packaged, we check the appearance, workmanship, function, safety of each product according to the customer's requirements at the location specified by the customer. Testcoo can strictly distinguish product quality and report the results of inspections to customers in a reliable and timely manner.



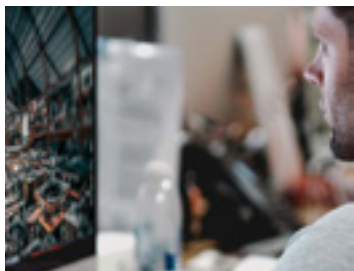
SAMPLE PICKING SERVICE (SPS)

Sample Picking Service (SPS) is performed when you pick shipment samples or testing samples allowing you to best assess whether the productions meet your quality needs and market standards. Testcoo ensures the samples are picked up from the mass production lot randomly to prevent samples “arranged” by the factory which can’t represent the mass production lot.

VIRTUAL INSPECTION

A virtual inspection also called remote inspection allows inspectors to guide factory staff remotely other than going to the factory by themselves through the steps of a product inspection, and collecting evidence of key findings on the product's quality and supply chain management.
